UNDERTAKING BY BOARDERS OF LADIES HOSTEL U.C.P. ENGINEERING SCHOOL, BERHAMPUR

I do hereby undertake to abide by the following rules and regulations of the hostel-

- 1. Ragging is strictly prohibited in any form, if someone is found guilty, severe action will be taken as per decision of Hon'ble supreme court.
- 2. Students are not allowed to consume any alcoholic, narcotic drugs or any intoxicating substance in the hostel premises. If found so, fine as deemed shall be imposed.
- 3. All visitors to the hostel including the parents/guardian will have to make necessary entries in the visitors book available at the hostel entrance with the security guard. They should provide a valid identity Proof. They are required to take permission from HS/AHS before entering to hostel.
- 4. Students should not keep any unauthorized property and/or unauthorized guests in their room.
- 5. No person/guests are allowed to stay overnight in hostel. If they want to, they may take prior permission from the HS/AHS.
- 6. Hostel boarders to take care of their own belongings. They have to lock their rooms properly before leaving to anywhere.
- 7. Students are not allowed to arrange any group religious activities in their room.
- 8. Students are not allowed to to take equipments, common room's furniture, newspapers/magazines/journals mess property etc, If so then appropriate fine shall be imposed from them.
- 9. Boarders to handle govt properties carefully and not to their break room or tamper equipments provided at any time .it. If so, then applicable fine will be charged by the hostel management.
- 10. Students have to use water and electricity judiciously. If fan, tube light, etc., are found ON in the absence of the students In their rooms, Rs 500/- per student fine will be charged by hostel authorities.
- 11. Garbage and wastage should only be put at garbage box available nearby hostel premises. They should voluntarily agree to take part in cleanliness drive every Sunday.
- 12. Students during their stay in the hostel will be governed by the hostel management rules ..
- 13. No student shall use the service of a hostel housekeeping person for personal work.
- 14. Students will not enter rooms of other students without permission of the inmates, if anybody is found, fine is to be charged.
- 15. Every case of illness and accident must be reported immediately to the hostel authorities.
- 16. No function or celebration shall be organized at hostel premises except with the permission of the Hostel Supdt.
- 17. Students suffering from contagious disease wont be allowed to stay at hostel. Decision of the Hostel Supt in this regard will be final & binding.
- 18. Allotment of room furniture etc. will be entirely at the discretion of the Care Taker and no complaint in this regard will be entertained. 19. All matters relating to differences among students and complaints against theft shall be brought to the notice of the hostel management. No police complaint will be lodged by the student before taking prior permission from the hostel management.
- 20. Appropriate disciplinary action shall be taken if any form of Mass-agitation/strikes/meeting/gathering is conducted without prior information to the authorities.
- 21. Hostel accommodation (room) can be changed by the management if they found it necessary at any point of time.
- 22. Students indulging in use of abusive and threatening language, physical fights, use of force to get unfair act accomplished, etc. will be punished. Further, they are liable to be expelled from the hostel/ Institute
- 23. Multimedia Playing music/record player etc. loud enough to cause disturbance to his/her neighbor(s) is prohibited.
- 24 Defaulter in will be punished. Repeated acts will render cancellation of allotment of Hostel room .
- 25.A hostel maintenance fee towards consumable items Rs. 100/- per month is to be paid by every boarder.
- 26. Study hours between 7.00 p.m. to 9.00 p.m are to be strictly adhered to and no one is allowed to leave and enter the hostel between 7:00PM to 9.00 P.M. The main gate will be remained lock.
- 27. Hostel mess bills are to be paid in between 1st to 10th date of every month. In case of non submission of the mess fees, a fine of Rs 500/- will be charged against nop paymet of dues in time
- 28. Chewing Gutkha, Paan masala inside hostel is strictly banned. If found any spitting, Rs 500/- from all in the corridor will be imposed.
- 29. EXCHANGE OF ALLOTTED ROOMS/SEATS without written approval from hostel authority will be treated as INVALID.
- 30. It's a responsible of every boarder to report the mishappenings in their room to the hostel authority. If any illegal activities happening in their room and no one has informed or accepting the mistake volunteerly, entire room will be charged against disciplinary action.
- 31. Hostel authorities will not be responsible againgst any case of MOBILE/VALUABLE ITEM'S THEFT CASES. Boarders have to lodge a complaint in B N Pur police station after informing authoritier in written application.
- 32. Boarders to submit application before leaving hostel for any reason and submit to HS/AHS for approval. Unauthorized or uninformed leave will not be considered as a valid case for discussion in any point of time.
- 33. Boarders are advised to bring their parents and meet HS/AHS at leat once per semester to know their ward's status.
- 34. Meals to be consumed in dining hall only. Any one found taking foods to the room will be imposed fine of Rs.500/-
- 35. While leaving the room in holidays, a copy of key in an envelop marking room no, names os student staying in that room, mobile number etc to be submitted to hostel authorities.
- 36. During the class hours, the power supply in the hostel will remain off.
- 37. Any one wish to terminate his hostel boarder ship, is to be done in official way by producing documents from the hostel authorities. The copy of the record has to be kept by the boarder for future reference.
- 38. Rules made time to time in hostel meetings will automatically assumed to be added here and aggred to follow by the boarders.
