

**TERMS AND CONDITIONS FOR ONLINE PAYMENTS**

These terms and conditions apply to the user who uses the Online Services provided for any payment made to UCP Engineering School, Berhampur. Kindly read these terms and conditions carefully. By authorizing a payment to Uma Charan Patnaik Engineering School through the online payment service ("the service"), it would be treated as a deemed acceptance to these terms and conditions. UCP Engineering School reserves all the rights to amend these terms and conditions at any time without giving prior notice. It is the responsibility of the user to have read the terms and conditions before using the Service. The following is a summary of the key terms of this service:

- (i) Payment(s) through this Service may only be with a Credit Card, Debit card, Net Banking or UPI.
- (ii) Before using this Service, it is recommended that the user shall make necessary enquiry about the charges or fees payable against the Credit/Debit card used from Credit Card or the Debit Card service provider i.e., the respective Bank.
- (iii) The credit card information supplied at the time of using the service is processed by the payment gateway of the service provider (Bill Desk) and is not supplied to Uma Charan Patnaik Engineering School. It is the sole responsibility of the User of the service to ensure that the information entered in the relevant fields are correct. 

**(E) Dispute Resolution**



**(F) Refund/Cancellation Policy**

Fees once paid will not be refunded under any circumstances. However, in case of dual or excess payments the students may contact the service provider (Bill Desk). The service provider (Bill Desk) will resolve the issues after verification of details and in consultation with the competent authority of Uma Charan Patnaik Engineering School. The whole process may take thirty working days.

- (i) In general, parent/guardian/student may browse this website for obtaining any data or information. However, in order to access the classified information, one needs to use the credentials provided as a Parent/Guardian/Staff/Student user.


- (iii) Online Fee Payment system purpose to provide flexibility and conform to its continuing student by offering option to pay online using various payment methods.
